The recent guideline of Municipal Affairs Department regarding preparation of Green Space Development Plan for the year 2016-2017 received from M.A.Department placed in the meeting by the Chairman for discussion and consideration.

Resolved that in order to develop green space in the Municipal area, necessary steps for preparation of Green Space Development Plan in order to achieve the target set under AMRUT Mission 15% will be taken up accordingly in phases within the time frame.

Board of Councillors unanimously resolved to adopt the guideline as received from M.A.Department as the Action Plan for the year 2016-2017 to achieve the reforms agenda under AMRUT and the Municipality will submit the Action Plan accordingly as per guideline.

Resolved that in order to reduce loss of treated water in the water supply system of the Municipality necessary steps for preparation of water loss reduction plan in order to achieve the target set under AMRUT Mission (i.e; less than 20%), Board of Councillors unanimously resolved to adopt the guideline as received from M.A.Department as the Action Plan for the year 2016-17 to achieve the reforms agenda under AMRUT.

Chairman, North Dum Dum Municipality has placed before the member that the issue regarding the reforms condition on AMRUT to "Adopt a policy of user charges for individual and institutional establishment in which a differential rate is charged for water use and adequate safeguards are included to take care of the interests of the interests of the vulnerable."

The matter was discussed elaborately by the members. After threadbare discussion, it was resolved that the water which are being supplied within the premises of the respective holdings of the bulk consumers like industrial units, commercial institutes will be charged for providing the drinking water as per rate decided by the Board of Councillors time to time. In addition to that, connection charges for supply of water within the premises of respective holding of the commercial institutes, industries, domestic purpose will be as per existing practice/ rate followed by the Municipality.

It was also resolved that at per with the policy of the State Government there will be no charge for supply of water to the economically weaker section including BPL households.
