

3. Bids received without Earnest Money deposit (EMD) shall stand rejected and thus shall not be considered for evaluation at any stage. The bid security without interest shall be returned to the unsuccessful bidders after finalization of the contract. EMD will be refunded to the lowest bidder after elapsing the contract period.
4. The EMD deposited by successful bidder will be adjusted towards the 'Performance Security deposit' after depositing further Rs. 3000.00 to the Municipality in a total amounting to Rs. 10000.00. If the successful bidder fails to furnish the difference amount between Security Deposit and EMD within 15 (fifteen) days after the issue of letter of award of work, his bid security shall be forfeited unless time extension has been granted by North Dum Dum Municipality.
5. The agency shall be solely responsible for compliance to provisions of various labour, Industrial and any other laws applicable and all statutory obligations, such as, wages, allowences, compensations, EPF, Bonus, Gratuity, ESI etc relating to contract personnel deployed in North Dum Dum Municipality (NDDM). The NDDM shall have no liability in this regard.
