If any Contractor withdraws his/their tender(s) within the validity period then Earnest Money as deposited by him/they will be forfeited and even a legal action may be taken by TIA. The TIA will accept the tender. He /She does not bind himself/herself to accept otherwise the lowest tender and reserves to himself/herself the right to reject any or all of the tenders received without assigning any reason thereof.
Declaration	i)A Declaration of warrantee of Street Light/Flood Lights for five(5) years from the bidder shall have to be submitted.

Other terms & conditions if any: -Penalty for suppression / distortion of facts :If any bidder fails to produce the original hard copies of the documents uploaded or any other documents on demand of the Tender Inviting Authority within a specified time frame or if any deviation is detected in the hard copies from the uploaded soft copies or if there is any suppression, the bidder will be suspended from participating in the tenders on e-Tender platform for a period of 3 (Three) years.
